Abstract

This paper aims to set the stage with an outline of the conceptual, analytical and theoretical aspects of water institutional reforms and a synthesis of the main findings from the reform experiences of six countries. Australia, Chile, Morocco, Namibia, South Africa and Sri Lanka.
